

Clear Brook FFA Booster Club Meeting Minutes

Tuesday, March 30,2010

The meeting was called to order at 6:35 p.m. The secretary, Dorothy See, read the minutes. Denise Christensen motioned to accept the minutes as is; and Kelly Seylar seconded the motion. The treasurer, Kelly Seylar, read the treasury report. The club's cash balance is \$8, 098.50. Jeanie Engle motioned to accept the treasury report as is; and John Valenti seconded the motion. The historian, Sue Bingham, had no information to report. Dennis Underwood, our web person, also had no information to report. Our president, Cheryl Hampton, says that our treasurer will write a check for \$100.00 tonight to pay for the ad that thanked the Project Show buyers for buying the CCISD students' animals and other FFA projects. Kelly Seylar will also write a check to Mr. Dickson for \$805.00 . This is the booster club's contribution money to help our students go on the 4 day judging trip in March.

Cheryl Hampton talked to the club about acquiring a sign for the Clear Brook Show Team. The Sign will include all the type of animals our students show. The booster club likes that idea and will vote on paying for the sign at a future meeting. Someone will look into different signs; and then the club will make the final decision. Cheryl Hampton also said that the officer position descriptions are out of date. The current officers have updated the descriptions and the booster club voted on accepting these updates. Angela Neil voted to accept the updated officer positions and Vicky Bland seconded the motion. Mr. Underwood will post the officer positions on the web site. Ms. Hampton will have a ballot made up before the April meeting. The club also discussed having our historian create a scrapbook of our students' FFA activities for next school year. Cheryl Hampton then asked for volunteers for the scholarship committee. Denise Altmeyer, Sue Bingham, Jeanie Engle, and Dorothy See volunteered for the committee. The FFA Banquet is going to be at the Webster Civic Center. We then voted to pay the \$100.00 deposit to acquire the place for Tuesday, May 18, 2010. Jeanie Engle motioned for the treasurer to pay \$100.00 deposit and Sue Bingham seconded the motion.

Mr. Dickson then discussed Chapter news. Mr. Dickson is leaving Clear Brook in order to take the FFA teacher position at Clear Falls High School. Our teachers will be Ms. Laura Malone and Ms. Meagan Stokley for 2010-2011. Mr. Dickson will go to State Convention in Corpus Christi with the students. Mr. Dickson discussed FFA record keeping meeting dates, Galveston County eligibility, Area judging date, Area Convention date, and Steer selection date. The State Convention is July12-16. The students' deposit amount is \$135.00, and is due to Ms. Stokley by April, 2010. The April Booster Club meeting is April 20, 2010. Jeanie Engle motioned to adjourn the meeting; and John Valenti seconded the motion. The meeting was adjourned at 7:21p.m.
